- Continue participation in Park District Flower Garden program
- Plan several social events for neighbors to get together
  - Some suggestions for consideration:
    - Dog walking event like the Humane Society's Mutt Strutt with games, treats and simple prizes
    - Ice cream social
    - Summer barbeque with hot dogs, hamburgers and games
- Schedule subdivision wide garage sale and clean-up events
- Consider planting evergreens to fill in gaps created by IDOT tree removal on I57
- Continue participation in goose egg addling with adjacent neighborhoods
- Vote on homeowner suggestion to harvest geese after 2024 nesting season

- Monitor vandalism and review options to improve neighborhood safety as needed
- Renew Pond / Board Insurance for 2024, consider other carriers to save money
- Remove additional invasive brush right at 100A western shoreline
- Get Aquatic Algae and Weed Control Certification for board member volunteers
- Continue DIY pond algae control, put additional focus on Lilly pads
- Repair most severely damaged retention pond shorelines as budget allows
- Remove dead / fallen trees in commons area as needed

#### **Aquatics**

#### ALGAE CONTROL CERTIFICATION FOR BOARD MEMBERS

 Online Training Courses are provided for licensure as an alternative method of self-study. These are self-paced courses allowing individual access for 30 calendar days from the date of purchase.

#### **3. Private Applicator Licensing Requirements**

- 1. Pass the 50-question private applicator exam with a score of 35 or more correct or the 100question General Standards exam or Aerial General Standards exam with a score of 70 or more.
- 2. Watch the mail for your license application.
- 3. Return the completed license application form with the appropriate fee to the Illinois Department of Agriculture.

The fee for a 3-year private applicator's license is \$30

#### 2023 GEESE ADDLING RESULTS


- Timberline Valley South 17 nests and 90 eggs
- Timberline Valley North 7 nests and 35 eggs
- Westlake 10 nests and 60 eggs
- Trails at Brittany 6 nests and 24 eggs
- Ponds on Windsor 15 nests and 64 eggs
- Robeson Meadows 7 nests and 31 eggs
- Total 62 Nests and 304 eggs in the local Champaign Area
- Harvest geese in 2024 after nesting season?
- Several homeowners have suggested since nearby subdivisions have done this

#### MUSKRATS AND RETENTION POND SHORELINE AND BACK YARD DAMAGE



- Professional trapper hired to reduce population
- Traps placed on 11/6
- Muskrat's nesting in your shoreline, will cause serious damage overtime to your shoreline and backyard
- Please contact the HOA if you are aware of a den on your shoreline so we can take action to prevent damage to the retention pond and your backyard



























## NEIGHBORHOOD WATCH

- Break in activity reported in Westlake
- Mail delivery issues observed on NextDoor and reported by TVS homeowners
- Informed Delivery is a free email service from USPS
- UPS also has a service to eliminate porch pirate loss
- As always, lock your car and park in garage to deter crime
- Some neighborhoods are reporting that landlords or property managers are not properly vetting renters leading to neighborhood issues
- We have not received any complaints, but nearby subdivisions have had issues

## SMART DOORBELLS & SECURITY CAMERAS

- A good investment if you have concerns
- It is recommended that you register your camera with Champaign PD
- They support deterrence, since cameras often help solve crimes

## **RETENTION PONDS**

- SOLITUDE was not responsive to requests for a maintenance quote in 2023
- Their videos are helpful with our DIY strategy
- DIY management was the only option for control of algae and odors
- Fewer geese and less fecal matter helps reduce nutrients in pond
- Several homeowners added RIPRAP, the best protection against Muskrat damage
- 100A pond watermeal problem improved with the removal of invasive plants
- We will use DIY strategy again next year to conserve budget and build reserve
- Efforts to get professional help hampered by limited access to ponds, esp. 100A
- There does not appear to be a simple inexpensive solution to 100A pond access





## OLD BUSINESS

- A few homeowners asked for a Bradley Crestwood intersection improvement
- We spoke to city about potential improvements
- Stop signs on Bradley at Crestwood were viewed as too disruptive by city
- A stop light at Staley and Bradley would be a possibility in future
- Another possibility is a stop light at Duncan and Bradley
- A new study of traffic patterns the city planner would be needed to justify \$\$\$
- No change planned in the near term based on most recent traffic study

## NEW BUSINESS

- Increase in vandalism reported in nearby subdivisions
- As always, keep your cars and homes locked and watch for suspicious activity
- Keep post lamps in working order and consider a smart doorbell
- Get license plate numbers if you can do so safely if you spot something unusual
- Some recent problems attributed to rental properties with irresponsible owners
- Some homeowners have suggested the HOA pass rules regarding rental units
  - Prospective renters must be vetted by landlord / property manager
  - A new owner cannot rent a property for one year to discourage landlord purchases
  - Renters must agree to abide by all neighborhood covenants
  - · Work with city to enforce home maximum occupancy rules
